If Elite Engineering determines that the product failure was the fault of the Company, and the product falls within the one year limited warranty period, a substitute product shall be replaced free of charge within 30 days of the Company's receipt of the product failure information from the purchaser. The decision as to the fault of the product failure shall be solely the discretion of Elite Engineering, and such decision shall be a final resolution of any product failure claim.
